

VALID IDENTIFICATION

The candidate must provide two (2) pieces of valid (non-expired) identification, one of which must be government-issued and include the candidate's name, date of birth, signature and photo. These forms also need to include a signed wet signature.

The following are accepted as government issued photo identification:

- Canadian passport

The following are accepted as supporting identification that could be submitted with the government issued photo identifications:

- Baptismal Certificate

- Hunting License
- Fishing License
- Canadian Blood Donor Card (only if date of birth is indicated)
- Immigration papers

The social insurance (SIN) card cannot be accepted as a piece of identification
